The budget is in better shape this year and includes a cost increase for electricity.

The response was that the requirements in that agenda item were in line with other College of Education programs, and that the language reflected accrediting agency requirements.

Dr. Bloodworth noted that with only “for your information” items on the agenda for the January 24<sup>th</sup> faculty meeting, there was insufficient reason to assemble the faculty, and the council concurred.
