**Minutes of Executive Committee**  
**February 19, 2008 9:00 am PKP Office, Reese Library**

**Members:** Ray Whiting (President), Jim Grayson (President Elect), Camilla Reid (Secretary).

Minutes of last Executive Committee meeting provisionally approved pending feedback from absent executive committee members.

There are nine outstanding initiation invitations: one from the College of Business and eight from the College of Education. Two students declined the invitation; one indicated she thought the \$52 membership fee was too high. Two graduate nominees were already initiated as undergraduates.

The online enrollment system has worked well, but there is concern that nine students have not responded at all. Camilla has sent multiple e-mails and made phone calls to these students. Jim Grayson will follow up with the COB student; Camilla will ask Peggy Ruth Geren about the best way to follow up with the COE students. Most of the nominees have accepted membership online with PKP headquarters; Camilla mailed forms and the personal checks of four nominees to headquarters.

Ray is contacting the two junior nominees with the highest GPAs. He should know by the chapter meeting on February 27<sup>th</sup> which one will be the chapter's first Student Vice-President.

There was discussion about which Executive Committee member will be able to represent the chapter at the PKP Partnering for Success event in Salt Lake City, May 30-June 1. It may be either Ray or Jim.

Student Research and Fine Arts Conference: Report by Jim Grayson. On March 14 there will be 81 participants and 24 faculty sponsors. There were 56 participants last year. The executive committee discussed the schedule and who would be responsible for what. Arranged by Chad Stephens, at 11:00 am in University Hall 170 there will be a plenary lecture, "Ebola Viral Infections: History and an Approach to Therapy," by Professor Stewart Schneller from the Department of Chemistry and Biochemistry at Auburn University. At 12:30 there will be introductions by Ray Whiting, President Bloodworth, and VP Sullivan, followed by a fine arts presentation. Poster presentation will be from noon to 2:30pm. Coordinated by Paul Harris, there will be two concurrent paper sessions from 1:00-2:15 pm and 2:30-3:45 pm. There will be a reception for all participants from 4:00 - 5:00 pm. Debbie Van Tuyl and her students are doing the program and posters to be posted on the office doors of PKP members.
