Minutes of the last meeting were corrected and approved.

5.3.H. All agreed "we are in Compliance with the **Must** but in Minimum Compliance with the **Should**. (*Must = Compliance; Should = Minimal Compliance*).

Ernestine made some general comments about section 5.1 noting the importance of addressing the issue of access for students with disabilities. She then read each item.
